
The Marine Corps League from Green Valley will be accepting donations for its annual Toys for Tots campaign at the

And your Chapter will be sending a thank you for your donation for tax purposes.



Chapter member, Navy CAPT Jeff McCune will be the featured speaker that night. Jeff will talk about the flag of the United States from its origin to present day and will include highlights from most of the battles that our flag has seen. Included will be some insights into the behind-the-scenes stories, such as the National Anthem, Iwo Jima, and 911. Unfortunately, there will be some reflections on the bad times that our flag has faced, such as the burnings, and disrespect shown by some now famous people. The gist of the talk will be about how the flag has withstood all of these challenges.

CAPT McCune is a natural for this topic because he is passionate about our Nation's flag and what it stands for. HIs father once said, "To be a good salesperson, you must believe in the product you are selling." After 32 years in service to his country, Jeff believes in the flag and what it represents. As a child he said the Pledge of Allegiance to the Flag every morning at



school. Today, kids don't do that. As a young teenager, he raised his hand and took the oath of enlistment swearing to support and defend the Constitution of the United States against all enemies..., and later, as a Navy Officer, he raised his hand again to support and defend, but also to bear true faith and allegiance to the same. Jeff proudly wears the US Flag with respect and pride. Over the years he watched as others belittled our flag, burned it, shredded it, and even refused to give their allegiance, making him all the more determined to study the flag, and tell others about our great flag. Many stories about the flag go untold, and in today's social environment, he just doesn't want those stories to be lost.

Jeff is a retired Navy Captain with 32 years of service, most of which were in the Reserves. His undergraduate degree is in Chemistry from the University of Kansas. He earned an MBA from Wichita State University, and Law degree from the Presidents College School of Law. He was awarded three National Defense Ribbons, a Legion of Merit, and many others. He also worked for the Boeing Corporation for 28 years in the Human Resources department. Jeff retired early from Boeing to go back onto active duty, where he served in Iraqi Freedom at Camp Arifjan in Kuwait, Landstuhl Army Hospital, and finally as the Deputy for Navy Reserve Medicine at the Bureau of Navy Medicine in Washington, DC. Jeff is married to an incredible retired Navy Nurse, Commander Myra McCune. Together they have five wonderful children and eight grandchildren.

Hearing Aid Assist Device at Quail Creek ⇒ If you are a member with Hearing Aids who still has difficulty hearing the speakers at the meal-plated meetings, Quail Creek does offer a Hearing Aid Assist Loop device. The Hearing Aid Assist is a loop system in the meeting room and can be turned on and individuals would wear a device around their neck which helps amplify the sound through their hearing aids. In order for this assist device to work the individual must have a Hearing Aid or Cochlear Implants with TeleCoil (T-Coil) capability. This device only works with hearing aids with this capability and will not work on individuals with no hearing aid at all.

MEMBER SPOTLIGHT: Get to Know Your Members

Eby-Deardorff assumed the position of Surviving Spouse representative for the Chapter in 2017. She is very quiet so the other board members were not aware of the adventuresome person she really is.

Betty was born and raised in a small town in central Pennsylvania. A bit ahead of her time when it came to women pursing a college degree, she commuted to Penn State in a 1937 Graham Paige. Though it was an out-of-date looking car, she related that because of the car's supercharger she could pass everything on the road!

After graduating from Penn State, she entered an internship program in medical technology at Henry Ford Hospital in Detroit earning an MS from Wayne State University. After completing her studies she returned to Bellefonte, PA and was hired as Chief Medical Technologist. Betty reported that her starting salary was \$300 per month, plus meals and a month long vacation.

In 1964 the hospital where she worked hired its first full time pathologist, John Deardorff. John had completed medical school during World War II and spent time in Europe and was called back to active duty for a brief period during the Korean War.

In 1966 Betty and John started a private clinical laboratory in State College, PA. They each put \$1500 of their own money into the lab and never had to add any more of their personal funds. During this time, Betty resumed her studies and earned a PhD in microbiology and biochemistry from Penn State.

Several years after John's wife died, Betty and John were married. After they sold their business they became "snowbirds" for a few years before retiring to Green Valley in 1996. They joined our Chapter where they enjoyed the programs and making new friends. After John died in 1999, Betty continued with the Auxiliary. She faithfully sells 50-50 raffle tickets before each meeting. She reported that she often shared the national magazine with her grandson before he joined the Navy.

Betty, who just turned 90, still plays 18 holes of golf twice a week. Thanks Betty for your continued support to our Chapter.




As Delays Continue, Help MOAA Fight to Speed Blue Water Navy Benefit Claims

Navy veterans who served in the waters off Vietnam may have won courtroom and legislative victories over the past several months, but they continue to wait for their earned benefits thanks to VA's stay on claims until Jan. 1, 2020. And while MOAA fights to provide VA with the resources it needs to speed up that process, these veterans face another delay in a process that could expand their eligibility for medical care and other benefits.

A November 2018 study by the National Academies of Sciences, Engineering and Medicine found multiple medical conditions linked to Agent Orange that are not included on VA's "presumptive diseases." A VA official told a Senate hearing in March that he expected a decision on adding these conditions to VA's list within 90 days. That deadline has long since passed, and recent reports suggest no new timeframe is in place for the update.

The delays in updating the list and in processing Blue Water Navy veteran claims continue to frustrate veterans and advocacy groups that have worked for years pursuing these benefits via both lawsuits and legislation. Another legal fight is underway seeking to end VA's stay on the claims, bipartisan efforts from lawmakers continue, and actions at the local level show veterans who've been affected by Agent Orange exposure have not been forgotten.

Add your voice to these efforts by helping MOAA push Congress to provide funds to the VA that would allow the department to expand staffing or update systems designed to speed these claims. Time is not a luxury afforded to many of these veterans, and delays on multiple fronts must be met head-on wherever possible. Contact your legislators on MOAA's Take Action page.

Hershey Hosts MOAA Council, Chapter Leaders and Spouses for Northeast Workshop

Nearly 120 MOAA council and chapter leaders and their spouses from six states came together in Hershey, Pa., Sept. 6-7 for the Northeast Region Council and Chapter Leadership Workshop. The workshop provided council and chapter officers with training specific to their leadership roles as well as updates about national MOAA.

The workshop began Friday afternoon with a welcome from MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret). Then, attendees were provided an overview of national MOAA's efforts, priorities, and challenges. This included details about the MOAA Scholarship Fund and the MOAA Foundation, along with the Community Outreach Grant program.

Attendees were informed about national MOAA's current marketing campaigns and resources. They were also given updates about the role of surviving spouses in the association and in councils and chapters, including the elimination of the <u>Survivor Benefit Plan-Dependency and Indemnity Compensation offset</u>, also known as the widow's tax. Then, they were given information on chapter incorporation and liability insurance, and the 2020 board of directors' election. The workshop divided into three breakout sessions the next day: chapter management training, legislative training, and surviving spouse training.

All attendees received a <u>workbook</u> that included presentations from each session of the seminar as well as other tips, resources, and contact information.

Congressmen Voice Support For Widows Tax Repeal At Maryland Council Luncheon

Repealing the widows tax was a key topic at this year's Maryland Council of Chapters' Congressional Appreciation Luncheon, where members of Congress gathered to discuss legislative priorities with MOAA members.

The Council thanked the Maryland delegation for their work in support of service members and veterans this past year, especially their push to repeal the widow's tax, which deducts annuity benefits paid to surviving spouses as an offset to a VA benefit for survivors.

MOAA has long supported the legislation to repeal the SBP-DIC offset and has ramped up efforts recently, including making it a primary agenda item during the <u>2019 Storming the Hill event</u>. The House's <u>Military Surviving Spouses Equity Act</u> and the Senate's <u>Military Widow's Tax Elimination Act</u> have garnered the support of more co-sponsors than ever before.

Lawmakers also expressed support for mandating a Defense Department review of <u>proposed cuts to medical billets</u>; maintaining Tricare fees; and increasing pay for active duty troops.

MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret), lauded the efforts of lawmakers who attended the annual luncheon.
