#### CHAPLAIN'S CORNER

I guess it was a few years back that I had a kind of "revelation" when understanding the Easter Story. From a small child I have heard the Easter story over and over again. Not in a boring way, but just trying to understand the true meaning(s) in the story. Or put a better way, answers the story provides. At times I would have a break-through in understand-ing one more point of the story. The Stations of the Cross was, I would say, a big revelation. So much that on Good Friday I started fasting and praying during this time (noon until 3 p.m.). Also, Jesus' humanity, when in the garden, asking God to take this cup (crucifixion) from him.

But the most telling, for me, was Jesus hanging on the cross and His resurrection from the dead three days later. This was truly the most enlightening event for me and my faith. As Jesus hung on the Cross, he had two robbers (one on each side) being crucified with him. Jesus' response to the robber that asked to be remembered was "today you will be with me in paradise."



So many questions were answered by this one statement. First, you are responsible for your actions even if you are saved. He did not save the robber from death, but forgave him his sins. At death, those that are saved will be with him instantly. Jesus didn't tell him you will be with me at some future time... but "today."

Easter brings the greatest opportunity to ensure you will be with him immediately by one simple act. The great Billy Graham stated "anyone who repents of sins and accepts Jesus Christ will be saved." Our only hope is in Jesus Christ. Seek and accept Him today!

# ADVOCACY IN ACTION 2022

Storming the Hill, a term which we have heard about for several years, has been replaced by "Advocacy in Action 2022". MOAA National is focusing on three issues:

- Major Richard Star Act: H.R. 1282/S. 344
- Stop Copay Overpay Act: H.R. 4824
- 4.6% Military Pay Raise

Leading the Arizona team to talk with Congresspersons and their staffers is Colonel Pete Kloeber, AZ Council of Chapters President. But we need your help. Please write to your Congresspersons and urge them to support the resolutions so that they pass sooner rather than later.

Following is a summary of the three bills:

#### Major Richard Star Act: H.R. 1282/S. 344

The Star Act will support 50,300 combat-injured veterans and is a concurrent receipt issue. Concurrent receipt may sound complicated, but it isn't:

- DoD is responsible for retired pay for vested years of service (in the past).
- VA is responsible for disability compensation for lifelong injury (in the future).
- These are two different payments for two different purposes. Congress acknowledged this as an injustice in the 2004 NDAA and partially fixed it.
- Instead, service members who were injured in combat and forced to retire face an offset in which their retirement pay is reduced for every dollar of disability compensation received from the VA.

To reduce retirement pay because of a combat-related disability is an injustice. Our combat-injured veterans earned their retirement pay through extreme personal sacrifice. This is not the place to seek out savings through an offset.

#### Stop Copay Overpay Act: H.R. 4824

Military Health System reforms have more than doubled TRICARE mental health copays over the last few years. Because mental health care often requires multiple visits, higher copays quickly add up and can make treatment unaffordable for many TRICARE families.

High copays are a fixable problem. Mental health care access is a challenge across the U.S. health care system. Surging demand coupled with a national mental health provider shortage means many families have difficulty finding appropriate care. TRICARE copay increases have created an additional financial barrier to access for military families — a barrier Congress can fix.

MOAA urges Congress to pass the Stop Copay Overpay Act. This bill (a Senate companion is needed) would reduce TRICARE beneficiary copays for mental health visits to make sure military families don't face a financial barrier to seeking mental health care.

#### 4.6% Military Pay Raise

Keeping our service members' wages competitive shows our Nation's commitment to the all-volunteer force. Based on current Department of Labor assessments, and reflecting the rising costs of employment, the FY 2023 NDAA should include a pay raise of 4.6%.

Undercutting the pay raise negatively impacts several groups:

- Recruits: Individuals considering whether to join the military may see this as an omen of things to come. Why join if pay will not keep up with the civilian sector?
- Currently serving: Those prepared to go into harm's way may see this as a slight to their service and sacrifice. Why stay if their sacrifice is not appreciated?
- Those about to retire: These service members may decide to get out soonest, taking their 20-plus years of experience to go work for a government contractor or some other enterprise and start building their next retirement as soon as possible.

All of these issues compound the difficulties not only for recruiters but also commanders who count on experienced leaders to accomplish the mission.


