SURVIVING SPOUSES CORNER: Making a VA Benefits Compensation Claim

I have been a surviving spouse for 24 years. My husband, a 33-year veteran of the Marine Corps and a naval aviator, died in 2001 from heart disease. He was never a member of MOAA. I became acquainted with MOAA in 2019 during a visit to Washington, D.C. It was a chance meeting during [Advocacy in Action](#), at which time some in the group learned I was the widow of a Marine Corps officer. I was led to the registration booth and immediately became a MOAA member. I learned there are approximately 47,000 surviving spouse members of MOAA — representing about 12% of the association's members. I'm now a proud Life member.

This brief encounter started a journey for me to be as active as possible. I became my local chapter's surviving spouse liaison and then a member of the Surviving Spouse Advisory Council (SSAC).

Through my involvement with MOAA, I learned about [VA Dependency and Indemnity Compensation \(DIC\)](#). As my husband served in Vietnam and was exposed to Agent Orange, it was determined his exposure subsequently caused the heart disease that contributed to his death. This qualified me to receive this benefit. With the help of a local veterans service officer (VSO) and the [VA Office of Survivor Assistance](#), I will receive this tax-free monthly compensation for the rest of my life.

Suppose you are the surviving spouse, child, or parent of a servicemember who died in the line of duty, or the survivor of a veteran who died from a service-related injury or illness. In that case, you might be eligible to receive this tax-free monetary benefit. [Visit the VA's website to learn more.](#)

For additional information and support, contact a local VSO if one is available in your community. Not all VSOs are as helpful as others, but I finally found mine.

To prepare for opening a VA claim for disability or other benefits compensation, applicants must possess the following documents:

- Military discharge (DD Form 214) — original or certified copy is best
- Other military service information (branch, dates of service, Reserve or National Guard service dates, etc.)
- Medical records (military and/or civilian) if available, and if applying for a service-connected disability, contact information for civilian medical providers who treated the veteran for military-related illnesses or injuries (i.e., doctors, specialists, hospitals, etc.)
- Bank deposit information (i.e., voided check) — the VA will automatically deposit into this account if benefits are awarded

If the above documents are not available, veterans or surviving kin can request them online at www.archives.gov/veterans.

Dear Fellow Officers, Spouses and Surviving Spouses,

As your Chapter President, I want to keep you fully informed about where we stand financially and what that means for 2026. Transparency has always been a hallmark of our chapter, and I intend to continue that tradition.

Current Fund Balances (as of 1 December 2025)

Scholarship and Military Assistance Fund: ~ \$13,000

General Operating Fund: ~ \$3,000

These balances reflect years of prudent management and, most importantly, your generous personal contributions. The Scholarship & Military Assistance Fund remains our pride – it is the primary source for the scholarships we award to JROTC cadets and veterans. It is also used for the emergency assistance we provide to veterans and military families in need. The General Fund covers chapter operations, meeting expenses, newsletters, and community outreach.

Looking Ahead to 2026

Corporate and community donations, which have supplemented our funds in the past, will be very limited next year. Several long-term sponsors have reduced or paused their support due to their own budget constraints. That means we will rely almost entirely on member dues, donations, and on our internal fundraising events that we can organize and support.

The good news: We start 2026 in solid shape because of YOU. The not-so-good news: If we want to maintain our current level of scholarships and continue helping veterans and families in crisis, we will need renewed and increased support and participation from everyone able to help.

Your past generosity and assistance have built these funds, and your continued support will determine what we can accomplish in the year ahead. Every dollar given to either fund stays right here in Green Valley and Tucson and directly benefits our military family – whether it's a deserving veteran college student or a veteran or military family facing unexpected hardship.

On behalf of the Board and every recipient who has been helped by this chapter, thank you – truly – for everything you have contributed to MOAA national and to our local programs.

Together we have made a real difference, and together we will keep the Green Valley Chapter strong.

JROTC UPDATE




New VA Benefit Overpayment Scam is Targeting Veterans

What This Fraud Looks Like and What To Do When It Shows Up

Veterans, surviving spouses, and family members who receive benefits are being targeted by a growing scam that mimics legitimate Department of Veterans Affairs debt notices. The scheme centers on false claims of VA benefits overpayments and uses realistic looking documents, emails, and text messages to pressure recipients into sending money or disclosing personal information.



The VA has confirmed this activity and issued a public warning. The fraud is not subtle. It relies on urgency, confusion, and the reasonable assumption that government benefits systems are complex and sometimes make mistakes.

How the Scam Works

Scammers pose as VA officials and contact beneficiaries claiming that a benefits overpayment has occurred. The communication often appears legitimate at first glance.

Common features include:

- **Fake VA letterheads and logos** that closely resemble official correspondence
- **Spoofed phone numbers or email addresses** that look like they originate from VA offices
- **Claims that you owe money immediately** due to an alleged overpayment
- **Pressure tactics**, including warnings about benefit suspension or legal action
- **Requests for payment outside VA systems**, such as wire transfers, cryptocurrency, gift cards, or prepaid debit cards
- **Requests for sensitive information**, including VA login credentials, banking details, or Social Security numbers

Each of these elements is designed to push the recipient into acting before verifying the claim.

What Legitimate VA Overpayment Notices Actually Look Like

Overpayments do happen. They usually result from changes in income, dependency status, incarceration reporting, or retroactive eligibility adjustments. When that occurs, the VA follows a defined process.

Legitimate overpayment notices:

- Appear in your **official VA.gov account**
- Are issued through the **VA Debt Management Center**
- Include clear explanations of the debt and your rights
- Provide structured options to dispute, request a waiver, or set up repayment plans

Never require immediate payment through third parties

If a debt is real, it will be visible when you log into VA.gov. There are no exceptions to this.

What To Do If You Receive One of These Messages

If you receive a letter, email, or text claiming you owe money to the VA, take these steps immediately:

Log into your VA.gov account

Check whether any debt is listed. If no debt appears, the communication is fraudulent.

Use only official VA channels

If a debt does exist, handle it directly through VA.gov or by contacting the VA Debt Management Center at **1-800-827-0648**.

Do not send money through nonstandard methods

The VA does not collect debts through wire transfers, cryptocurrency, gift cards, or peer to peer payment apps.

Never share login credentials or sensitive information

The VA will not ask for passwords, authentication codes, or banking information through unsolicited contact.

Avoid clicking unknown links or attachments

Many scam messages contain malicious links designed to steal data or install malware.

Do not pay anyone claiming they can fix your VA debt for a fee

VA debt assistance is available at no cost. Any demand for upfront payment is a red flag.

How To Report VA Overpayment Scams

If you suspect a scam:

Contact the VA directly at 1-800-827-1000

Report fraud to the Federal Trade Commission

Use **VSAFE.gov** or call **(833) 38V-SAFE** for additional reporting options. Patterns matter. Reports help investigators identify active campaigns and disrupt future scams.



Why This Matters

This scam succeeds because it borrows credibility from real administrative processes. Veterans are not careless for taking these messages seriously. They are responding to systems they earned through service.

Fraud prevention is not just about individual awareness. It is also about clear communication, consistent verification tools, and peer level information sharing. Veterans talking to other veterans remains one of the most effective countermeasures.

Bottom Line

If a message about a VA overpayment creates urgency, asks for unusual payment methods, or requests personal information, pause. Verify through VA.gov. If it is real, it will be there. If it is not, report it.

Staying cautious protects your benefits, your identity, and other veterans who may be targeted next.

Shopping at Fry's Can Help Our S&MA Fund

Here's a painless way to support the Chapter's Scholarship and Military Assistance (S&MA) Program. If you shop at Fry's, you can link your VIP Awards Card to our Chapter, and the company will automatically make a deposit into our S&MA Account. And no, it won't impact your ability to earn points for gasoline purchases. Even purchase of adult beverages qualify for the Community Awards program.



If you have been donating to another charity, you can change your desired charity preference, but the money cannot be divided between two charities.

Beds for Service Dogs

Traditionally Chapter members were given gifts from the Chapter at holiday time, an activity that became more labor intensive and expensive over the years. And many members commented that they already had more than enough holiday decorations or other decor than they needed. The Board recommended to the members who wholeheartedly approved the idea that instead of buying gifts for them, we could donate something to veterans.

We learned that the VA works with blind veterans to get them guide dogs to make their lives easier. The veterans then go through a resident program in which they learn skills necessary to compensate for their loss of vision with their dog at their side. In the evenings, the veterans return to their apartments with the service dog. Dogs being dogs often tried to get into bed with their veteran. It was our Chapter to the rescue when they shopped for large dog beds with washable covers for the veterans.

In addition to four dog beds, the Chapter purchased a Netflix subscription which the VA will use to train veterans how to access a program that describes the scenes as well as hear the dialogue for TV shows and movies. A special thanks to Lisa Larkin whose generosity helped fund the purchase.

But at Christmas time she goes all out to make life a little more pleasant for the homeless veterans. In true military style, she recruits her neighbors at Quail Creek to support her efforts to gather needed items.



Irene, a retired logistics officer, is used to keeping detailed records by counting or weighing items. Her Santa collection results were no exception. This year her efforts netted: 50 pairs boxer briefs, 6 hats, 5 scarves, 8 pr gloves, 13 lbs. of soaps and body wash, 6 lbs. of toothbrushes/toothpaste (including a box of 100 toothbrushes), 3 lbs. dental hygiene (floss, etc.), 2 lbs. lotions, 3 lbs. personal hygiene (shampoo, conditioner, deodorant), and 400 paper napkins.

When the donations were delivered to the VA just before Christmas, the staff was delighted to receive so many thoughtful and needed items. Thank you, Irene and all your friends in Unit 24.






MOAA National News

The **Major Richard Star Act**, a bipartisan effort to fix a long-standing injustice in the military retirement and disability compensation system, has taken a significant procedural step in Congress as lawmakers look to move the issue forward before the end of the year.



The MOAA-supported bill ([H.R. 2102](#) | [S. 1032](#)) eliminates a dollar-for-dollar offset faced by servicemembers whose combat-related injuries force them to medically retire before the 20-year mark. Ending this “[wounded veteran tax](#)” would allow eligible veterans to receive both full retirement pay and full disability compensation.

In a strategic shift to advance the legislation in this session of Congress, Sens. Richard Blumenthal (D-Conn.), Mike Crapo (R-Idaho), and Elizabeth Warren (D-Mass.) have filed the text of the bill as an amendment to House-passed appropriations legislation ([H.R. 4016](#)).

That House bill contains five of the [12 annual funding bills](#) often viewed as must-pass legislation for federal operations, including money for:

Defense
Commerce, Justice and Science
Interior

Labor/Health and Human Services
Transportation/Housing and Urban Development

By offering the Major Richard Star Act as an amendment to this package, sponsors hope to give members of both chambers an opportunity to vote on the issue in the context of essential federal spending legislation.

Why This Matters Now

Attaching the legislation to must-pass funding bills represents a key shift in advocacy strategy as the first session of 119th Congress winds down. Because the standalone bills have faced procedural hurdles over the past seven years, leveraging the appropriations process may provide the best remaining opportunity to secure floor consideration and a recorded vote in the coming weeks.

MOAA continues to highlight that this reform carries modest budgetary impact relative to its importance to veterans' families and supporters, and stresses that military retirement pay and disability compensation are distinct entitlements earned through service and sacrifice.


